Cangany, Jr. (the "Reporting Person") on April 25, 2019. Such award of REUs to the Reporting Person vested 25% on the date of grant, and the remaining 25% in three equal annual installments on April 1st of each subsequent calendar year.
- 2. Includes 15,000 shares of Class A common stock issuable upon settlement of an award of 12,000 REUs to the Reporting Person granted pursuant to the 2018 Equity Incentive Plan on April 1, 2022. Such award of REUs to the Reporting Person shall vest 40% on June 8, 2023, and the remaining 60% in three equal annual installments on April 1st of each subsequent calendar year.
